NO DIVING FROM ANY RENTAL BOATS

DUFFY ELECTRIC - 2 BOAT, 21' LONG, FIBERGLASS HULL; ELECTRIC MOTOR; LIMITED TO INSIDE THE HARBOR ONLY. **THE BOAT MUST STAY IN HARBOR. NO DIVING AND NO FISHING** FROM THESE BOATS. FUN, SAFE, EASY TO OPERATE. WE FURNISH LIFE PRESERVERS FOR EACH PASSENGER AND ONE PADDLE.

IT WILL HOLD UP TO 10 PASSENGERS.

SKIFFS - 2 BOATS 16 FT LONG. LG SKIFF HAS STEERING WHEEL; ALUMINUM HULL, 9 H.P. OUTBOARD MOTOR (SM: WITH TILLER AT REAR FOR STEERING); **SUFFICIENT GAS IN TANK FOR 4 HRS. SKIFFS CAN ONLY GO 1 MILE OUTSIDE THE HARBOR.** WE FURNISH LIFE PRESERVERS FOR EACH PASSENGER, AND ONE PADDLE BOAT WILL HOLD UP TO 4 ADULTS OR 2 ADULTS AND 3 CHILDREN IF THE CHILDREN ARE LESS THAN 90 LBS. EACH. YOU MAY FISH FROM THESE BOATS.

LIDO 14 - 1 BOATS, 14' LONG; FOR "SAIL" ONLY, MAINSAIL AND JIB, GOOD SAILING BOAT. HAS FIXED KEEL FOR GREATER STABILITY. YOU CAN USE ONLY MAINSAIL IF DESIRED. **THE BOAT MUST STAY IN HARBOR. NO DIVING, NO FISHING AND NO MOTOR.** WE FURNISH LIFE PRESERVERS FOR EACH PASSENGER AND ONE PADDLE.

UP TO 5 PASSENGERS

CATALINA 22 - 2 BOATS, 22' LONG; **SAILBOATS WITH 5 H.P. MOTORS** AND SUFFICIENT GAS FOR 4 HRS; MAINSAIL AND JIB, SAILS HAVE A LARGE EMB ON MAINSAIL AND BOAT HAS A SMALL CABIN (SOME SEAT CUSHIONS); THE MOTOR IS USED FOR THE PURPOSE OF LEAVING AND ENTERING THE HARBOR ONLY (IF NEEDED) **THEY ARE NOT RENTED AS MOTORBOATS AND SHOULD NOT BE DEPENDED UPON AS SUCH.** WE FURNISH LIFE PRESERVERS FOR EACH PASSENGER, AND A PADDLE. **THE CATALINAS 22's ARE LIMITED TO A MAXIMUM OF TWO MILES OUTSIDE OF THE HARBOR.** FOR EASIER AND SAFER RETURNS TO THE HARBOR, SAIL TOWARD NORTHWEST.

THE SAILBOATS WILL HOLD UP TO 7 PASSENGERS IF SOME ARE SMALL

CAPRI 22 - 4 BOATS, 22' LONG; **SAILBOATS WITH 5 H.P. MOTORS** AND SUFFICIENT GAS FOR 4 HRS., MAIN SAIL AND JIB (W/ROLLER FURLING), SAILS HAVE A LARGE EMB ON MAINSAIL AND BOAT HAS A SMALL CABIN (SOME SEAT CUSHIONS); THE MOTOR IS USED FOR THE PURPOSE OF LEAVING AND ENTERING THE HARBOR ONLY. **THE SAILBOATS ARE NOT RENTED AS MOTORBOATS AND SHOULD NOT BE DEPENDED UPON AS SUCH.** WE FURNISH LIFE PRESERVERS FOR EACH PASSENGER, AND A PADDLE. **THE CAPRI 22's ARE LIMITED TO A MAXIMUM OF TWO MILES SAILING OUTSIDE OF THE HARBOR.** FOR EASIER AND SAFER RETURNS BACK TO THE HARBOR, SAIL NORTHWEST. **THE SAILBOATS WILL HOLD UP TO 7 PASSENGERS IF SOME ARE SMALL.**

FLYING LATEEN - 1 BOAT, 16.5' LONG KEEL SAILBOAT FOR IN-HARBOR USE ONLY. RIGGING IS CALLED FLYING LATEEN - **MAXIMUM 3 ADULTS OR 2 ADULTS AND 2 CHILDREN. DESIGNED FOR EASY HANDLING, THIS BOATS BRINGS AN UNMATCHED LEVEL OF PERFORMANCE AND CONFIDENCE TO SAILING.**

NOTES - ALL SAILBOATS ARE FIBERGLASS CONSTRUCTION. THE ONLY WAY WE RESERVE BOATS IS IF THE ALL DAY RATE IS PAID IN ADVANCE. **NO REFUNDS.** IF RENTER DOES NOT KEEP BOAT OUT ALL DAY, THEY STILL MUST PAY THE FULL DAY RATE. WE DO NOT GUARANTEE WEATHER CONDITIONS AND WILL NOT MAKE ADJUSTMENTS IN RATES DUE TO WORSENING WEATHER. VMP WILL NOT RENT TO ANYONE IF HE/SHE OR GUEST HAVE OBVIOUSLY BEEN DRINKING, USING A CONTROLLED SUBSTANCE OR SEEM OVER MEDICATED. IF THIS CAUSES A PROBLEM WE WILL IMMEDIATELY CALL DANA POINT POLICE OFFICE AT 248-3580 OR EMERGENCY 9-1-1. EACH BOAT IS CHECKED, CLEANED AND IF APPLICABLE FUELED EACH MORNING AND AGAIN AFTER EACH RENTAL. IF CUSTOMER RETURNS BOAT AND CLAIMS DAMAGE CAUSED AN EARLY RETURN, VMP WILL NOT MAKE ANY ADJUSTMENTS OR REFUNDS- WITHOUT THE APPROVAL OF MANAGEMENT OR SENIOR PERSONNEL ON DUTY. THE PERSON MAKING THE DECISION MUST WRITE ALL INFO REGARDING CIRCUMSTANCES AND ATTACH TO RENTAL FORM. IF IT IS DETERMINED THAT CUSTOMER HAS CAUSED THE DAMAGE VMP MUST VERIFY ALL INFORMATION ON HIM/HER INCLUDING RESIDENCE, BUSINESS ADDRESS (A POST OFFICE BOX IS NOT SUFFICIENT) AND CURRENT PHONE NUMBERS. VMP WILL RETAIN ANY DEPOSIT MADE TO US.
